## Leanna Brown '56 Fellowship Application

The Leanna Brown Fellowship is made possible by the generosity of Leanna Brown's father, Harold Young, and is intended to support Smith students working at summer internships in state or local government, or in organizations (government or non-government, domestic or international) focused on issues of particular concern to women.

Students from all departments are invited to apply, although priority is given to Government majors. The amount of the award varies depending on the number of applicants and the amount available in the fund during a given year. Over the last few years, the average award has ranged from \$500-\$1,000.

Please be aware that the rules governing other Smith College funds may preclude award of multiple funds for a single summer internship, and thus may require that you offset your awards. Students may combine Praxis funds with Leanna Brown funds, capped at a combined total of \$4,400. Please check with the administrators of other Smith College funds from which you are securing support to determine if an offset is necessary.

Both in-person and remote internships qualify for consideration.

## Leanna Brown '56 Fellowship Agreement

Read the following carefully, and sign below indicating that you understand these fellowship award guidelines and agree to abide by them. Be sure to read the description of the Fellowship on the Government web page.

- Priority for Leanna Brown '56 Fellowships is given to Government majors and to unpaid internships.
- Students considered for a Leanna Brown '56 Fellowship must be currently enrolled and in good academic standing. Students who are temporarily withdrawn, or withdraw for any reason during the application process, will no longer be eligible. Graduating seniors are also ineligible.
- Applicants must be working at an internship whose mission falls within the parameters of the donors' intentions. The Leanna Brown '56 Fellowship is intended to help with internships affecting women's issues and/or state/local politics.
- Proof of employment in the form of an offer letter from the employer cited in the application must be submitted before any funds awarded will be paid.
- Awards to some non-US students may be subject to US federal tax withholding up to 30%. Those taxes can be recovered after filing the US tax return if the awardee qualifies. Tax issues can be discussed with the Smith College controller's office.
- A comprehensive budget of your internship-related expenses and income sources must be submitted at the same time as your application form.
